This Amendment No. 1 is being filed jointly by the Reporting Persons and amends the Schedule 13G initially filed by the Reporting Persons with the Securities and Exchange Commission (the "SEC") on April 12, 2019 (the "Schedule 13G").

Except as set forth below, all Items of the Schedule 13G remain unchanged. All capitalized terms not otherwise defined herein shall have the meanings ascribed to such terms in the Schedule 13G.

Item 4. Ownership.

(a) and (b):

As of close of business on December 31, 2019, each of the Reporting Persons may have been deemed to have beneficial ownership of 423,524 shares of Common Stock, which consisted of (i) 909 shares of Common Stock issuable upon an exercise of a warrant held by Intracoastal ("Intracoastal Warrant 1"), (ii) 100,000 shares of Common Stock issuable upon an exercise of a second warrant held by Intracoastal ("Intracoastal Warrant 2"), (iii) 322,580 shares of Common Stock issuable upon an exercise of a third warrant held by Intracoastal ("Intracoastal Warrant 3"), (iv) 8 shares of Common Stock issuable upon an exercise of a fourth warrant held by Intracoastal ("Intracoastal Warrant 4"), and (v) 27 shares of Common Stock issuable upon an exercise of a fifth warrant held by Intracoastal ("Intracoastal Warrant 5"), and all such shares of Common Stock in the aggregate represent beneficial ownership of approximately 0.4% of the Common Stock, based on (1) 120,612,570 shares of Common Stock outstanding as of November 12, 2019 as reported by the Issuer, plus (2) 909 shares of Common Stock issuable upon an exercise of Intracoastal Warrant 1, (3) 100,000 shares of Common Stock issuable upon an exercise of Intracoastal Warrant 2, (4) 322,580 shares of Common Stock issuable upon an exercise of Intracoastal Warrant 3, (5) 8 shares of Common Stock issuable upon an exercise of Intracoastal Warrant 4, and (6) 27 shares of Common Stock issuable upon an exercise of Intracoastal Warrant 5.

(c) Number of shares as to which each Reporting Person has:

(i) Sole power to vote or to direct the vote: 0.

(ii) Shared power to vote or to direct the vote: 423,524.

(iii) Sole power to dispose or to direct the disposition of 0.

(iv) Shared power to dispose or to direct the disposition of 423,524.
